

WREGIS Assignment Termination Notice

WREGIS Administration

Instructions:

- This Notice of Revocation or Termination of Assignment form must be completed, signed and submitted to the WREGIS Administrator in order to effectuate the revocation or termination of a previously submitted **Notice of Assignment of Registration Rights**. This notice will only be effective upon the WREGIS Administrator's acknowledgement of acceptance by email or by online completion of the requested change.
- Notice of Revocation requires only the signature of the entity(ies) or person(s) that owns or controls the Generating Unit or its output (Generator Owner(s)) that executed the original Notice of Assignment.
- Notice of Termination requires *both* the signature of the Generator Owner(s) and the Assigned Account Holder that executed the original Notice of Assignment.
- If any Generating Unit (or its output) subject to this Notice of Revocation or Termination is co-owned or controlled, the Notice must be signed by all Generator Owner(s).
- All Generating Units subject to this Notice of Revocation or Termination must be accurately listed and identified. WREGIS will assume that the Generating Units not identified below are *not* subject to this Notice of Revocation or Termination.
- The applicable WREGIS procedures and rules governing assignment of registration and account management rights and obligations, and the revocation or termination of such rights and obligations are as set forth in the **WREGIS Operating Rules** and Account Holder Registration Agreement (also known as the "**Terms of Use**"). Parties filing this notice are advised to consult these WREGIS documents. If you have any questions, please call WREGIS at the number indicated below.
